### Distribution of contributions (volume wise) .

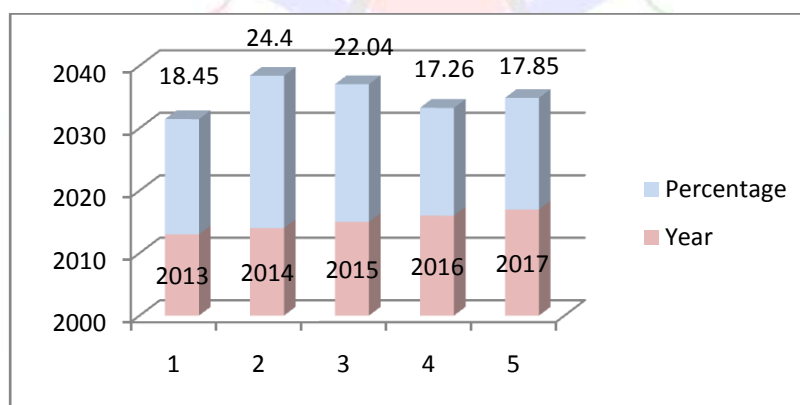
The distribution of contributions is shown in table No.1

### Authorship Pattern of Contributions

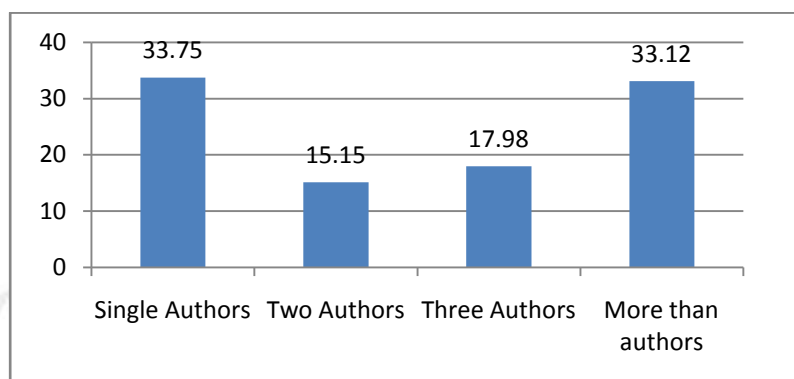
The authorship pattern of contributions is for shown in Table No.2.

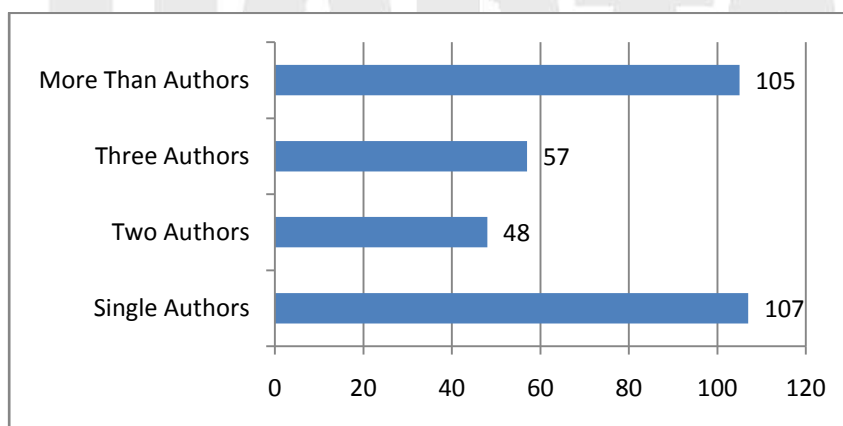
The authorship pattern of contributions is revealed in table in 4 given below.

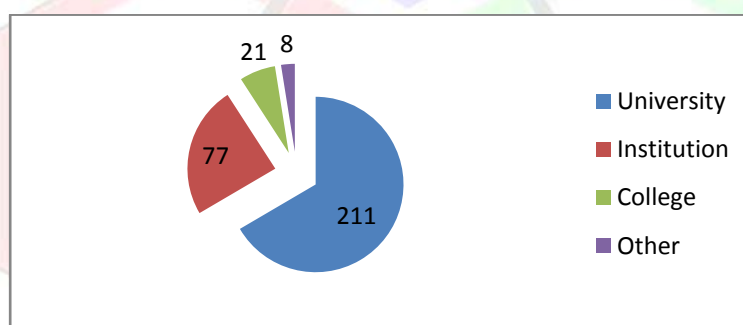

**Figure no. 4 Institution wise contribution.**



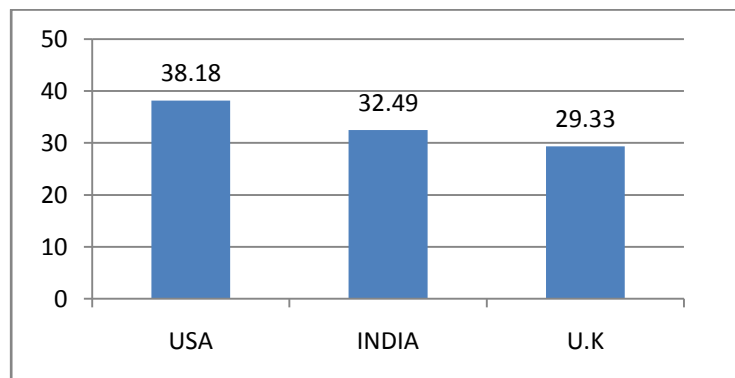

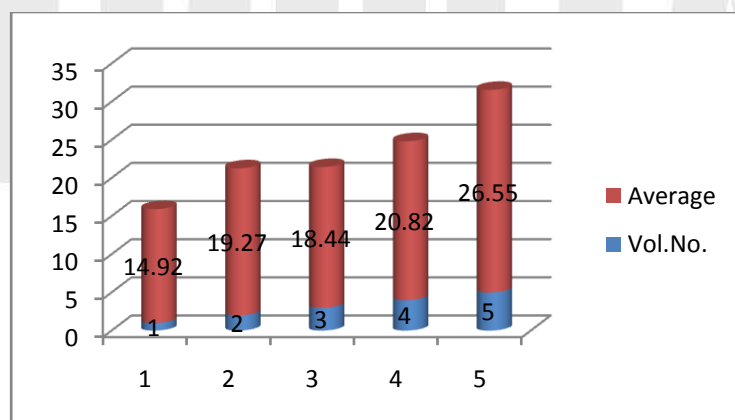

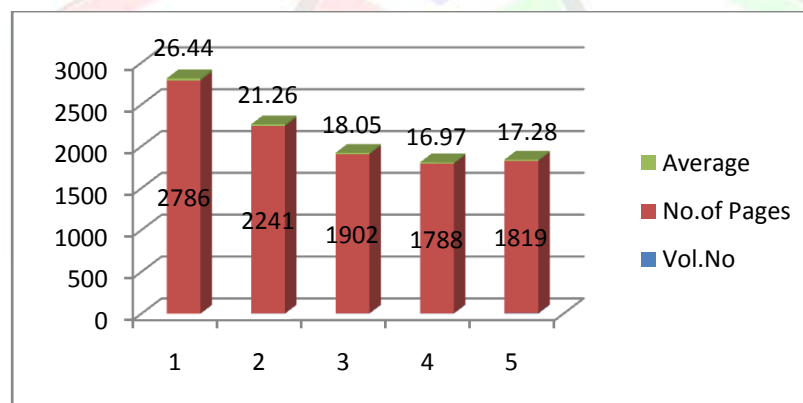
