Distribution of contributions (volume wise) .

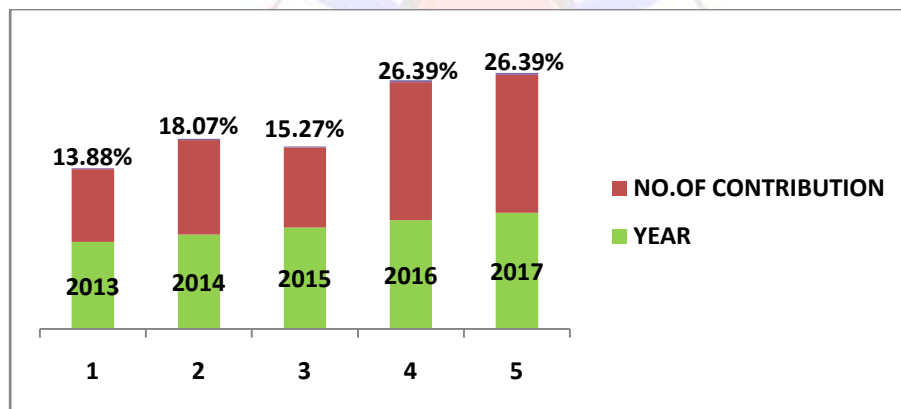
The distribution of contributions is shown in table No.1

Authorship Pattern of Contributions

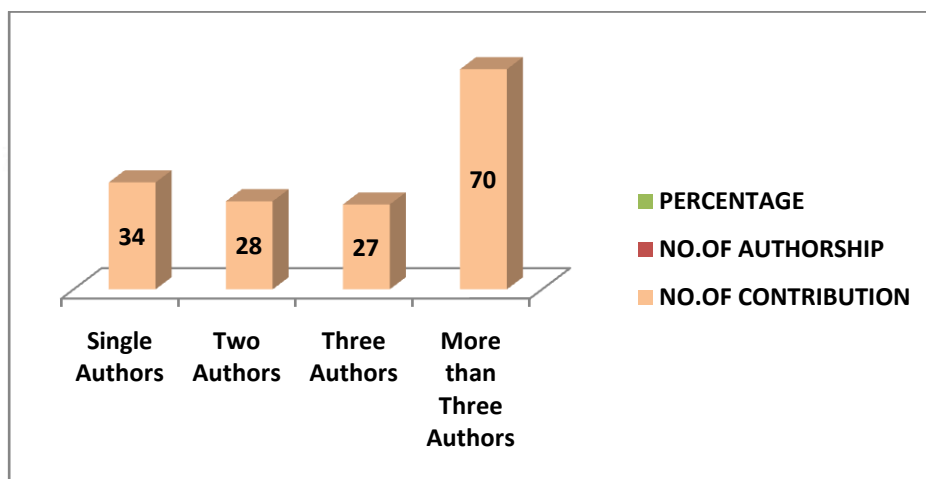
The authorship pattern of contributions is for shown in Table No.2.

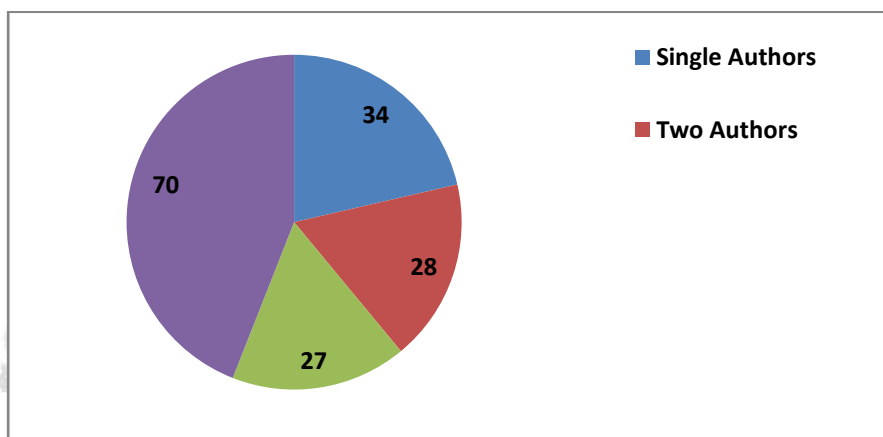
The authorship pattern of contributions is revealed in table in 4 given below.

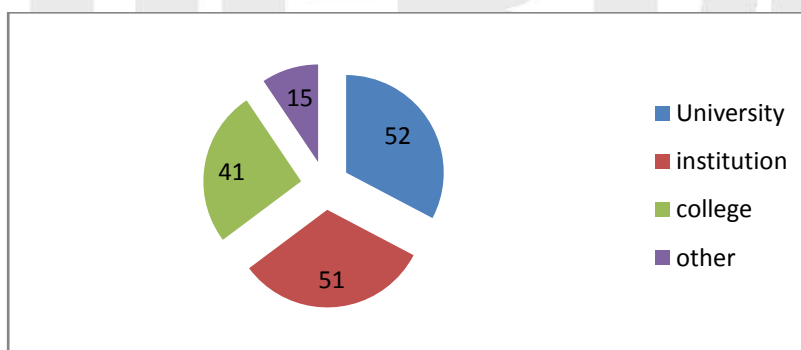

Figure no. 4 Institution wise contribution



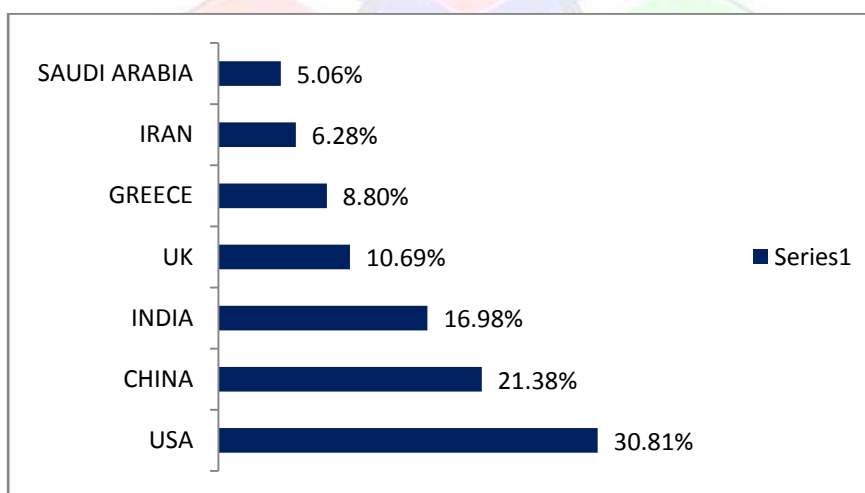

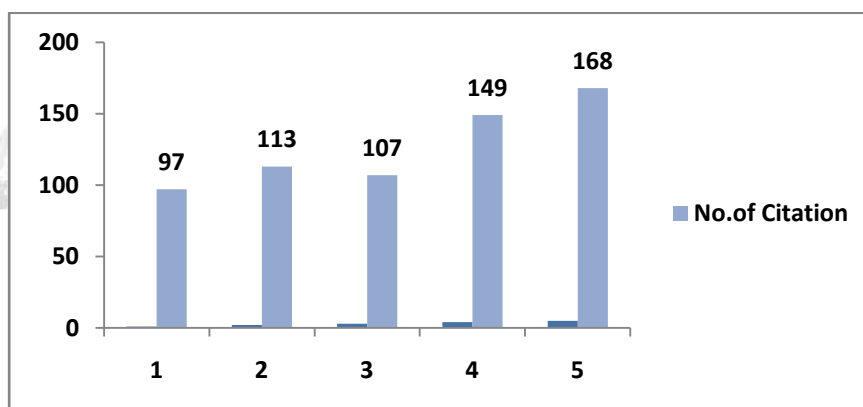

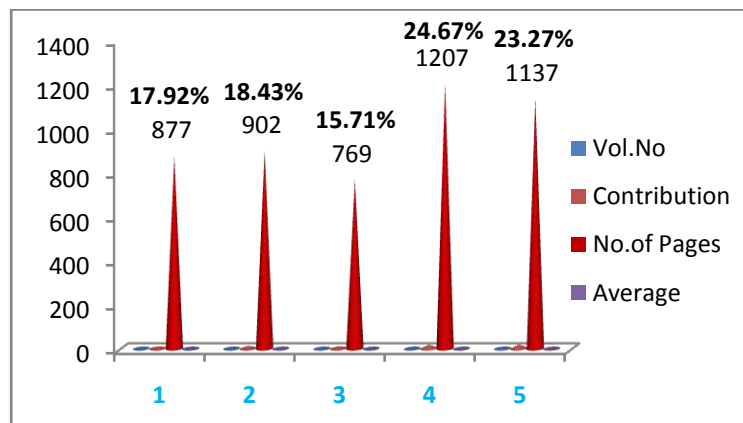
